#### Agenda item No.1: Review of Previous Council Minutes and Actions

#### **Notes:**

Governing Body Council members reviewed the deliberations made on various issues in the previous meeting and actions for improving the functioning of the college.

#### <u>Agenda item No.2:</u> Principal Ratification and New Teaching and Non-Teaching faculty member's Appointment of Faculty.

#### **Notes:**

The Governing Body Council resolved the following issues regarding recruitment:

#### A. University (JNTUH) revised policies of recruitment need to be followed for Faculty Recruitment:

This emphasizes the importance of aligning the faculty recruitment process with the updated policies and guidelines set forth by JNTUH. It ensures that the recruitment procedures are in line with the university's expectations and standards.

#### B. The faculty selection committee needs to be changed according to JNTUH norms:

This implies that the composition of the faculty selection committee should be in accordance with the norms and guidelines established by JNTUH. The selection committee plays a crucial role in ensuring a fair and transparent recruitment process.

#### C. Faculty ratification is to be done with the university:

This suggests that once the faculty selection process is complete, there should be a formal ratification or approval process with the university. This step ensures that the selected faculty members meet the university's criteria and standards.

#### D. Faculty with cross-degree qualifications need to be reviewed:

This highlights the need to thoroughly review and assess faculty members who possess qualifications spanning multiple disciplines or degrees. It ensures that their qualifications align with the specific requirements of the positions they are being considered for.

### E. It should be observed to have both Subject experts and University representatives on the selection committee for the recruitment process as per revised rules:

This underscores the importance of having a balanced selection committee that includes both subject matter experts and representatives from the university. This diverse composition ensures a comprehensive evaluation of candidates, considering both academic expertise and institutional perspectives.

In summary, these guidelines appear to prioritize adherence to university policies, committee composition, and a thorough review of faculty qualifications to enhance the quality and fairness of the recruitment process at JNTUH.

# Agenda item No.3: NAAC – Accreditation Process and its Implementations and 2(f) Application Process and increase in intake in CSE 60 to 120 Seats

#### **Notes:**

#### A. NAAC Accreditation Application:

The Principal, Dr. Nagendra Singh, is advised to file the DVV application for NAAC (National Assessment and Accreditation Council) Accreditation. This is a significant quality assurance process for higher education institutions in India. Achieving accreditation from NAAC reflects the institution's commitment to academic excellence and quality assurance.

#### **B. Preparation for NAAC Accreditation:**

The Governing Boday Members recommendation suggests that the institution should prepare comprehensively to meet the criteria and standards set by NAAC. This involves ensuring that the institution's infrastructure, teaching-learning processes, research activities, and overall governance meet the required benchmarks.

#### C. Recognition and Reputation Building:

Sri D. Prashanth Reddy Garu the Chairman of the Governing Body added the word The goal of obtaining NAAC Accreditation is not only compliance but also to enhance the institution's recognition and reputation. Achieving accreditation is often seen as a mark of quality and can contribute to the institution's standing in the academic community.

#### D. Emerging as a Premier Institution:

The overarching objective is for the institution to emerge as a premier educational institution. This involves not only meeting accreditation standards but also excelling in various aspects of education, research, and overall institutional development.

#### E. Application for UGC 2(f) Process:

Sri D. Prashanth Reddy Garu the Chairman of the Governing Body added the word in addition to NAAC Accreditation, the recommendation includes applying for the UGC (University Grants Commission) 2(f) process. This process involves obtaining recognition from the UGC, which is a statutory body in India responsible for coordinating, determining, and maintaining standards of university education.

In summary, the Governing Body Council's recommendations aim to elevate the institution's status by obtaining NAAC Accreditation, preparing comprehensively for the accreditation process, and seeking recognition through the UGC 2(f) process. #### Agenda item No.6: Academics and Co-curricular Activities.

Dr. Nagendra Singh appraised the academic and co-curricular activities, and he also discussed the following issues in this regard and the Council consented.

- a) It is appreciated to conduct tasks beyond and above the syllabus as Learn Emerging Advances in Domain (LEAD) experiments in every Lab course and suggested conversion of one into a Hobby project, wherever it is possible.
- b) Advanced courses like Android, AI and CAD / MATLAB-based learning/training are suggested in the existing 'Advance Technology Lab (ATL).

#### Agenda item No.7: Research Activities

Sri. D Prashanth Reddy suggested promoting the research centers to enhance the student's technical skills and bridge the gap between Academics and Industry to excel in academic services.
